Huoy-Ming Yeh founded Upshot Ventures in 2015, which when joined with CSC formed the firm's early-stage focused venture capital fund CSC Upshot Ventures. In close partnership with AngelList, Upshot defines a new model of venture investing online, combining large-scale intelligent data analysis with unique deal access to deliver superior risk-adjusted early stage returns. Investments include Cruise, Checkr, Roofstock, Circle Medical and many others.

Ming is a deep technologist with more than 15 years of experience in venture capital and over 10 years of experience in technology companies. Prior to founding Upshot, Ming headed up SVB Capital Asia as Managing Director for SVB Financial Group. In this role, she led SVB's venture capital investment activities and managed all aspects of SVB's relationships with venture capital and private equity communities in Asia. Before joining SVB Capital, Ming cofounded PacRim Venture Partners, a venture capital firm based in Silicon Valley. Formerly, Ming was with the Investment Banking Advisory group at Lehman Brothers. Her background includes substantial technology expertise, as a design engineer for Sun Microsystems, Key Computer Labs (acquired by Amdahl), and Prime Computer. During her tenure at Sun, she earned three patents for her work on the UltraSPARC processor.

Ming's leadership roles outside of work reflect her passion for bridging Asian-American culture as well as her devotion to investment in women in leadership roles. She serves on the Board of Governors for the China Venture Capital and Private Equity Association (CVCA), an organization that promotes the interest and development of the venture capital and private equity industries in China. Ming is Past Chairperson of Women In Leadership, a premier women's leadership group whose members are senior leaders in the venture capital and private equity communities in China. She also sits on the Wellesley College Business Leadership Council, supporting the college in its mission to educate women who will make a difference in the world.

Ming holds an M.B.A. from Massachusetts Institute of Technology, a master's degree in electrical engineering from the University of Southern California, and a bachelor's degree in physics from Wellesley College. Fully bilingual (Mandarin and English) and fully bicultural, Ming is an experienced panelist and speaker. She is a marathon finisher, skier and photographer.
